台灣檢驗科技股份有限公司(以下簡稱SGS),經與歐萊德國際股份有限公司(以下簡稱歐萊德),桃園市龍潭區中豐路高平段18號,達成雙邊協議,依據ISO 14064-3:2006之要求執行直接與間接溫室氣體排放量之查驗,溫室氣體排放量涵蓋期間自2020年01月01日至2020年12月31日,查驗聲明內容說明如下:

### 角色與責任

歐萊德管理階層確保組織溫室氣體資訊系統之發展、紀錄維護及文件化程序已符合標準要求,負責評估、決定及報告溫室氣體排放量資訊,並提供支持溫室氣體主張所需之其他資訊給SGS。

SGS秉持第三方查驗單位之準則,依據2021年07月14日簽訂之雙邊協議、ISO 14064-1:2018、ISO 14064-3:2006要求,於2021年09月09日至2021年09月29日期間執行溫室氣體排放量查驗活動,並根據歐萊德適用範圍、目標、準則及溫室氣體排放量涵蓋期間自2020年01月01日至2020年12月31日之查驗結果,提出溫室氣體查驗聲明。

### 保證等級

SGS依據查驗準則及雙邊協議執行查驗程序,針對歐萊德於溫室氣體主張所提類別一及類別二之查驗 證據顯示,未違反實質性差異門檻,符合主管機關認可之合理保證等級。

### 查驗目標

SGS獨立客觀的取得支持溫室氣體主張揭露資訊的佐證,確保報告資訊符合準確性、完整性、一致性 及透明度之準則,其內容包含錯誤或遺漏之項目。

### 查驗準則

遵守下列相關標準要求執行溫室氣體主張之查驗:

### 實質性

歐萊德定義溫室氣體主張符合性之實質性差異門檻判斷準則為5%,SGS依據此準則確認溫室氣體揭露 資訊之遺漏或錯誤程度。

### 結論

歐萊德依據查驗準則要求提出溫室氣體主張,揭露資訊涵蓋期間自2020年01月01日至2020年12月31日,期間溫室氣體排放量為 14,537.446 公噸二氧化碳當量及生質燃燒之二氧化碳排放量為 0.0000公噸二氧化碳當量。SGS採用風險評估方法為基礎,確保並控管溫室氣體排放資訊揭露風險;規劃及執行查驗流程,包含行前評估、取樣計畫、證據之蒐集,取得查驗聲明需要之資訊、說明及相關佐證,確保揭露之溫室氣體排放量準確性。



SGS has been contracted by Hair O'right International Corporation (hereinafter referred to as "O'right"), No.18, Sec. Gaoping, Zhongfeng Rd., Longtan Dist., Taoyuan City 32544, Taiwan for the verification of direct and indirect Greenhouse Gas emissions in accordance with

### ISO 14064-3:2006

as provided by Hair O'right International Corporation (hereinafter referred to as "O'right"), No.18, Sec. Gaoping, Zhongfeng Rd., Longtan Dist., Taoyuan City 32544, Taiwan, in the GHG Assertion in the form of GHG report covering GHG emissions of the period 01 January 2020 to 31 December 2020.

### Roles and responsibilities

The management of O'right is responsible for the organization's GHG information system, the development and maintenance of records and reporting procedures in accordance with that system, including the calculation and determination of GHG emissions information and the reported GHG emissions.

It is SGS's responsibility to express an independent GHG verification opinion on the GHG emissions as provided in the GHG Assertion for the period 01 January 2020 to 31 December 2020.

SGS conducted a third party verification of the provided GHG assertion against the principles of ISO 14064-1:2018, ISO 14064-3:2006 in the period 09 September 2021 to 29 September 2021. The verification was based on the verification scope, objectives and criteria as agreed between O'right and SGS on 14 July 2021.

### **Level of Assurance**

The level of assurance for category 1 and category 2 agreed is that of reasonable assurance.

#### Scope

O'right has commissioned an independent verification by SGS Taiwan of reported GHG emissions of O'right arising from shampoo and cosmetic product producing activities, to establish conformance with ISO 14064:2018 principles within the scope of the verification as outlined below.

This engagement covers verification of emission from anthropogenic sources of greenhouse gases included within the organization's boundary and is based on ISO 14064-3:2006.

- Location/boundary of the activities:

- Physical infrastructure, activities, technologies and processes of the organization:
   Shampoo and cosmetic product producing.
- GHG sources, sinks and/or reservoirs included: Sources as presented in the inventory spreadsheet provided by O'right.
- Types of GHGs included: CO<sub>2</sub>, CH<sub>4</sub>, N<sub>2</sub>O, HFCs, PFCs, SF<sub>6</sub>, NF<sub>3</sub>
- The IPCC 2013 AR5 GWP values are applied in this inventory.
- Emission factor:

### **Objective**

The purposes of this verification exercise are, by review of objective evidence, to independently review:

- Whether the GHG emissions are as declared by the organization's GHG assertion
- The data reported are accurate, complete, consistent, transparent and free of material error or omission.

### Criteria

Criteria against which the verification assessment is undertaken are the principles of ISO 14064-1:2018.

### Materiality

The materiality required of the verification was considered by SGS to 5%, based on the needs of the intended user of the GHG Assertion.



### Conclusion

O'right provided the GHG assertion based on the requirements of ISO 14064-1: 2018. The GHG information for the period 01 January 2020 to 31 December 2020 disclosing emissions of 14,537.446 metric tonnes of CO<sub>2</sub> equivalent and 0.0000 metric tonnes of direct CO<sub>2</sub> emissions from the combustion of biomass are verified by SGS to a reasonable level of assurance, consistent with the agreed verification scope, objectives and criteria.
